### 2. HAZARDS IDENTIFICATION

#### EMERGENCY OVERVIEW

DANGER. CORROSIVE. CAUSES IRREVERSIBLE EYE DAMAGE. CAUSES SKIN BURNS. MAY BE FATAL IF ABSORBED THROUGH SKIN. HARMFUL IF SWALLOWED.

**Principle routes of exposure:** Eye contact. Skin contact. Inhalation.  
**Eye contact:** Corrosive. Causes irreversible eye damage.  
**Skin contact:** Corrosive. Causes permanent damage.  
**Inhalation:** May cause irritation and corrosive effects to nose, throat and respiratory tract.  
**Ingestion:** Corrosive. Causes burns to mouth, throat and stomach.

### 4. FIRST AID MEASURES

**Eye contact:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes. Get medical attention immediately.  
**Skin contact:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Get medical attention immediately.  
**Inhalation:** If breathing is affected, remove to fresh air. If person is not breathing, call 911 or an ambulance and then give artificial respiration, preferably by mouth to mouth, if possible. Get medical attention immediately.  
**Ingestion:** Call medical attendant, doctor, or poison control center immediately. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Never give anything by mouth to an unconscious person.  
**Notes to physician:** Probable mucosal damage may contraindicate the use of gastric lavage.  
**Aggravated Medical Conditions:** Individuals with chronic respiratory disorders such as asthma, chronic bronchitis, emphysema, etc., may be more susceptible to irritating effects.

### Storage:

Protect from freezing. Keep tightly closed in a dry, cool and well-ventilated place. KEEP OUT OF REACH OF CHILDREN.
